ARENA - Centre for European

Studies (originally Advanced Research on the Europeanisation of the Nation-State) was established as a ten-year research programme in 1994. In 2004, ARENA became a permanent part of the University of Oslo as a research centre based at the Faculty of Social Sciences.

ARENA is an internationally recognised research community, which studies the ongoing processes of political integration and change in Europe. ARENA's aim is to conduct theoretically founded and empirically informed basic research; to publish in internationally renowned journals and publishing houses, and to enhance cooperation with other leading research communities.

ARENA is an integrated research centre organised around a set of core research themes. It consists of a community of active researchers organised in several coherent

sub-groups. The researchers interact regularly with national and international colleagues, not least through a number of research projects and at international conferences, but also at in-house seminars and workshops such as the institutionalised ARENA Tuesday Seminars.

In 2012, ARENA researchers undertook research within a number of projects, published widely, and reported research findings at a large number of external and internal academic and other events.

In 2012, the continual financial crisis of the Eurozone has been the focus of attention of scholars as well as of the general public all over Europe and beyond. The crisis has left a lasting imprint on the institutional architectonic of the European Union. This has not only added complexity to the field of European studies but also exacerbated the democratic challenges facing the EU. At the same time, the EU's importance for peace

through institution-building was recognised by the Nobel Peace Prize Committee. This was a reminder of the EU's values and important contribution to the pacification of the international relations in Europe.

Norway's peculiar political situation has increasingly attracted public attention. For most practical purposes Norway is a de facto EU-member, because of the many agreements it has with the Union, such as the EEA and Schengen. Norway's close relationship with the EU, its dependence on the European integration process, has been documented by ARENA researchers over the years.

These are some examples of ongoing developments that pose politically salient and academically pertinent questions for the ARENA research team. The financial, economic as well as the social and political crises, and the necessary reforms discussed in the EU today occupy a prominent place in the research agenda of the national and international networks and projects, which the centre coordinates and participates in. There is an urgent need for more research and knowledge of the unprecedented processes of integration (and possibly disintegrating) processes in Europe and the democratic problems they bring to the fore. ARENA has suggested new research projects, which deal with recent developments within the European political order and society(ies) and the intricacies they represent for the prospects of a democratic Europe.

In addition to the development of new research projects and several large-scale applications to Norwegian and European agencies in 2012, funding **ARENA** researchers ran several research projects including EuroTrans (The Transformation and Sustainability of the European Political NORCONE (The Norwegian Constitution in a Changing European Context) and FLAGSHIP (European Flagship Universities), all financed by the Research Council of Norway. The EPISTO project (Why not Epistocracy? Political legitimacy and the fact of expertise), also financed by the Research Council of Norway, commenced in 2012.

ARENA staged several public events in 2012, such as the ARENA lecture by Seyla Benhabib on 'Challenges to Cosmopolitanism in Contemporary Europe', the 1814 lecture by Jan-Werner Müller on 'Fear and Freedom' and a Partnerforum seminar on the EU and the Nobel Peace Prize.

This report contains the main research activities at ARENA in 2012: the Centre's publications, events and dissemination activities.

Research agenda

The research at ARENA is dedicated to the study of the European political order and how it is transformed through processes of political integration. The research at the centre is organised in line with the four main research areas of the *EuroTrans* project, which cover the following dimensions:

- the administrative-regulative dimension of the political order;
- the constitutional-democratic dimension of the political order;
- the cognitive-cultural dimension of the political order;
- the external dimension of the political order.

ARENA is involved in several large and small projects funded by different sources. Some projects are initiated and coordinated by ARENA researchers, such as the EPISTO, NORCONE and FLAGSHIP projects, but ARENA also participates as a partner in a number of projects and networks coordinated at other universities and research institutions across Europe, and beyond.

The Transformation and Sustainability of the European Political Order (EuroTrans)

The multilevel constellation that makes up the European Union is a unique political system. In the EuroTrans project we ask: How are decisions made at the many levels of the EU? Which are the processes of democratisation? How is the EU changing and what are the consequences for its citizens and member states?

About

The traditional model of democratic rule is based on national control and the territorial delimitation of sovereignty. In Europe this has been supplemented with forms of supranational governance, direct participation and representation.

The EU is an innovative order, providing answers to some of the challenges facing the nation state, but at the same time raising questions about how this order ensures effective action and democratic self-determination in a globalised world. The EU's multi-level system of governance, with its local, national and supranational elements, represents an experimentarium for research on the conditions for democratic rule and change.


The research under EuroTrans covers the following dimensions of the political order:

- The administrative-regulative dimension
- The constitutional-democratic dimension
- The cognitive-cultural dimension
- The external dimension

Objectives

EuroTrans studies the direction, dynamics and sustainability of the evolving European political order.

- What are the key characteristics and components of the new emerging order?
- What are the implications for member states' governing arrangements and for



the citizens of Europe?

- How robust is this new system and what are the conditions for change?
- How can the multilevel constellation that makes up the EU be assessed from the point of view of democracy and rule of law?

The Norwegian Constitution in a Changing European Context (NORCONE)

Some claim that in today's Europe the constitutional-democratic character and legitimacy of the EU's member states can no longer be established without taking the effects of the EU properly into account. If so, does this also apply to a closely associated non-member such as Norway? And, what are the implications for the ability of Norwegian citizens to govern themselves through law and politics?

About

NORCONE (The Norwegian Constitution in a Changing European Context) examines how Norway's constitutional development is tied up with and affected by the EU.

Constitutions always evolve in their international contexts. Legal developments beyond the nation state are profound, not least as a consequence of the European Union, which many analysts and decision-makers understand as a constitutional order. Formally speaking, Norway is not a member of the EU. However, it is closely affiliated with it, first and foremost through the European Economic Area (EEA) Agreement, but also through the Schengen Agreement, and a range of other agreements.

Objectives

The main purpose of the project is to establish the nature of the EU's constitutional developments as well as the constitutional implications for Norway which stem from its relationship with the EU. Are Norwegian citizens able to govern themselves autonomously through politics and law within the new European context?

This project takes as its main point of departure the challenges and opportunities for democracy in international society. International developments raise the question of the relationship between constitution and

sovereignty. It challenges the idea of national sovereignty safeguarding constitutional rule, and thus the protection of citizens' rights and interests, which in turn enables and justifies democracy.

The development of systems of rights and law enforcement beyond the nation state has first delimited, and later redefined, the principle of state sovereignty. In Europe this development has been particularly strong due to the existence of the EU, an organisation capable of rights enforcement. The focus of NORCONE is on the implications of the European integration process on Norwegian constitutional democracy. It addresses the broader process of juridification, and the role and status of the Norwegian Constitution and the implications for democracy.

NORCONE will result in two books: one in English on Europe's democratic-constitutional development; and one edited volume in Norwegian integrating and synthesising a, for now, fragmented and dispersed knowledge base with reference to Norway's relations to the EU. This book will update existing knowledge and establish a conception of Norway's constitutional-democratic status.

The project will conclude prior to the 200th anniversary celebration of the Norwegian Constitution in 2014. The aim is to stimulate a qualified public debate on the living constitution of Norway in light of the principles laid down in 1814, the inspiration and genesis of which are truly European.

Why not EPISTOcracy? Political legitimacy and 'the fact of expertise'

The EPISTO project examines and assesses the legitimacy of expert rule in modern democracies with a particular focus on the European Union and the European Commission's expert groups.

About

The EU has recently taken unprecedented administrative and legal measures to address threats of terror, the euro crisis, and environmental challenges. Critics claim that the Union's crises management contributes to pushing the EU further towards technocracy and expert-rule.

Is Europe abandoning democracy as we know it? And if so, is this a problem? Some would say no. To deal with the risks and hazards globalisation throws upon us, they would argue, the best available expertise must be mobilised and given the necessary power, even if we by doing so are challenging familiar ideas of democracy. If more power to the experts can help save the planet, the economy, health, security and other basic goods, we should not hesitate embracing it or worry so much about democratic standards. Why stick to ideas of 'rule of the people' that may turn out to be irrelevant and even dangerous in a world that is in urgent need of decisions based on our best knowledge? Why not opt for what political philosopher David Estlund refers to as 'epistocracy' - a 'rule of the knowers'?

EPISTO will elaborate on this and other arguments for expert-rule, test the soundness of their empirical assumptions, and develop a sophisticated and robust normative defense of democracy in Europe that specifies the legitimate role and scope of expert power.

Objectives

The EPISTO project will:

- elaborate on different dimensions of knowledge-based rule and develop an epistocracy-typology
- discuss and identify the proper standards for assessing the normative legitimacy of expertise arrangement based on recent contributions and debates in political philosophy and democratic theory
- map and analyse the European Commission's expert group system, its composition and powers
- study expertise behaviour, deliberation and rationality in the context of this system, and discuss and assess this system's normative legitimacy in light of its empirical characteristics

European Flagship Universities Balancing Academic Excellence and Socio-Economic Relevance (FLAGSHIP)

The FLAGSHIP project examines and compares the strategies of Norwegian and other Western European universities in adapting to a global context that requires a better balance between academic excellence and socio-economic relevance.

About

FLAGSHIP examines the ways in which European flagship universities have adapted over the last ten years to far-reaching changes in their political and socio-economic environments, and the extent to which these adaptations are initiated and implemented by the institutional leadership or as a consequence of external change drivers.

A 'flagship' university is defined as a comprehensive research-intensive university,

located in one of its country's largest urban areas. A flagship university is in general among the oldest and largest institutions for higher learning of its country.

Objectives

The overall objective of this project is to produce relevant insights into the way in which selected flagship universities in Europe interpret and use their institutional autonomy in creating an effective balance between strengthening the excellence and securing the socio-economic relevance of their academic activities.

The project addresses the following two questions:

- What are the organised settings and institutional characteristics that attract highly qualified staff and students, encourage academic excellence and free enquiry and also make universities take seriously their social and economic responsibilities?
- What are the main factors that over the last ten years have affected these organised university settings and institutional characteristics?

For understanding the way in which European research-intensive universities adapt their strategies, structures, policies and practices, one has to understand how specific university actions relate to European-level ambitions and interventions, as well as to the national legal, financial-economic, and political traditions and realities. Based on this understanding, the strategic room to manoeuvre that these universities have, as well as the way in which they use this autonomy, will be examined.

This will be done through case studies of nine selected institutions. These are 'flagship' universities in small nations in Northern and Western Europe: Universities of Copenhagen, Helsinki, Oslo, and Stockholm, the Universities of Amsterdam and Leuven, and the Universities of Vienna and Zurich.

FLAGSHIP's aim is to provide Norwegian universities and policy makers with a better understanding of the change dynamics of flagship universities in selected other European countries and the ways in which changes in Norwegian universities compare to these. The aim is further to contribute to the discussion on the autonomy of Norwegian universities and university colleges, as well as to the strengthening of the knowledge basis of Norwegian knowledge area policies, especially in the areas of research and innovation.

Menu for Justice — Towards a European Curriculum Studiorum on Judicial Studies

A common legal framework and a convergent judicial culture represent one of the pillars on which the European integration process has been pivoting since its very beginning. Today, more than ever, the understanding and the maintenance of the tempo and the direction of the integration need to rely on a common language with which Europeans and European policy makers develop a dialogue across domestic and cultural differences.

Menu for Justice is the first European project that takes seriously the issue of how young generations should be trained in law and legal matters and how the prospective experts of law and courts should be provided of new skills and competences to effectively face the challenges of a common judicial space. With 50 partners in Europe, the project aims at assessing principal shortcomings of legal education, developing an innovative curriculum studiorum in judicial studies, and offering the EU and the public basic guidelines to monitor the way legal and judicial training are changing in the EU, all over the cycles of education (from undergraduate to graduate, PhD programmes and vocational learning).

Responding to Complex Diversity in Europe and Canada (RECODE)

The process of nation-building has generally been described in terms of struggles for territorial concentration of power, political participation and social rights. Many of these conflicts can be equated with the development of industrial society. Since then, social and political alignments have experienced a great change. What could be deemed the *simple diversity* of industrial societies has given place to a new, *complex diversity* in which a variety of social, political and cultural cleavages overlap and compete for political legitimacy at a national and supranational level.

RECODE's concern is that within a context wherein the nation state may no longer sustain its role as the dominant social organisation and mode of community, these cleavages may interact in such a manner as to pose particularly demanding challenges (but also offer possibilities) for the political authorities. RECODE examines four issue areas in depth in order to achieve a clearer sense of complex diversity, its implications for public policy, and policy suggestions: diversity; linguistic de-territorialised diversity; religious diversity, and; diversity and redistribution.

Linking Interdisciplinary Integration Studies by Broadening the European Network (LISBOAN)

As of December 2009, the Lisbon Treaty has become the EU's new fundamental framework for the foreseeable future. The analysis of altered or novel treaty provisions has consequently become a high priority for interdisciplinary research-based teaching curricula in EU studies. LISBOAN promotes synergies between research and teaching, highlights innovative approaches and establishes best practices in teaching this key issue to present and future generations of students. It also includes an annual 'Lisbon Watch'.

LISBOAN is a network of 67 partner institutions from 32 countries, covering all EU member states as well as Croatia, Iceland, Liechtenstein, Norway and Turkey, and includes the key disciplines of economics, history, law, and political science.

Parliament Staff – Backgrounds, Career Patterns and Behaviour of Officials in the European Parliament

As the European Parliament (EP) has grown both in competencies and power, its administrative apparatus has become professionalised and increased considerably in number. This development has not yet been studied thoroughly. What kind of administration the EP has is not a minor matter as over 6000 officials currently work for the EP, in addition to the secretariats of the various political groups They take increasingly part in the drafting of policy documents and stay in contact with lobbyists, and thus provide important decision-making premises.

This project examines the policy-making role of the EPs Secretariat and the secretariats of the political groups. It unveils *which* concerns and *whose* arguments officials in the EP assign weight to when shaping the informational foundation for policy-making.


Rethinking Democracy and the European Union

Erik Oddvar Eriksen and John Erik Fossum (eds) Routledge, 2012

While the Lisbon treaty was meant to clarify the European Union's role and political identity, it remains a challenge for politicians and decision-makers to define. Rethinking Democracy and the European Union looks at both the concept of the EU as a political system, questions whether EU politics require a new theory of democracy, and evaluates the relationship between union and state, and the possible future of post-national democracy.

The book draws upon leading scholars and practitioners from the ARENA coordinated RECON project to frame and analyse a range of institutional realms and policy fields, including constitutionalisation, representative developments, gender politics, civil society and public sphere, identity, and security and globalisation.

In addition to the editors, the following ARENA staff has also contributed to this volume: Christopher Lord, Agustín José Menéndez, Hans-Jörg Trenz, and Helene Sjursen.



Transnational Citizenship in the European Union

Past, Present and Future

Espen D. H. Olsen Continuum, 2012

This book argues that European citizenship is transnational, a status that has emerged incrementally during the European integration process.

It follows an institutionalist approach and traces the development of citizenship discourse from the founding treaties of the EU to the most recent effort of constitution-making and the Lisbon Treaty. This helps demonstrate that such discourse has followed a path based on the foundational principles of free movement and non-discrimination rather than revolutionary ideas of a postnational citizenship beyond the nation-state.



Multilayered Representation in the EU

Parliaments, Courts and the Public Sphere

Christoher Lord (with Tatjana Evas and Ulrike Liebert) (eds)

Nomos Verlagsgesellschaft, 2012

The evolving European Union brings up vital questions about where democracy is heading. This book contributes to this discussion by offering critical appraisals and constructive propositions by eminent experts engaging with the novel configuration of 'multilayered representation'.

Key issues are the 'European Multilevel Parliamentary Field', the role of European Jurisprudence for representation, and the emerging European public sphere.

The volume includes several contributions from ARENA staff, including John Erik Fossum, Asimina Michailidou and Hans-Jörg Trenz.



The Agency Phenomenon in the European Union

Emergence, Institutionalisation and Everyday Decision-making

Jarle Trondal (with Madalina Busuioc and Martijn Groenleer) (eds) Manchester University Press, 2012

One can observe a new international interest in the Arctic amid a certain expansion of the rule-of-law principle in the international arena. The Arctic is on the agenda of the European Union, and also the new globalised world affects this unwelcoming region.

The contributors to this special issue of *International Journal* look at how globalisation is affecting the Arctic. They discuss how the Arctic has opened up: is the region completely open, or does it have regulated access? To whom has it opened up: is the region open to anybody, only for invited multinational corporations or only to other Arctic states? And, finally, what is opened up: common areas, border areas or domestic areas, or all of the above?

ARENA-affiliated contributors include Morten Egeberg and former PhD fellow Maria Martens.



The Politicization of Europe Contesting the Constitution in the Mass Media

Hans-Jörg Trenz (with Paul Statham) Routledge, 2012

This book examines how mass media debates have contributed to the politicisation of the European Union. The public controversies over the EU's attempted Constitution-making (and its failure) sowed the seeds for a process of politicisation that has advanced ever since: an increasing visibility for the EU in mass-mediated public debates that is combined with a growing public contestation over Europe within national politics.

The book presents an original systematic study of the emerging field of political discourse carried by the mass media in France, Germany and Britain to examine the performance of Europe's public sphere. Whilst the EU's increasing politicisation can be seen as beneficial to European democracy, potentially 'normalising' the EU-level within national politics, the same developments can also be a threat to democracy, leading to populist and xenophobic responses and a decline in political trust.

Such discussions are key to understanding the EU's legitimacy and how its democratic politics can work in an era of mediated politics.



The EU's Common Foreign and Security Policy The Quest for Democracy

Helene Sjursen (ed.) Routledge, 2012

This book reorients the study of European foreign and security policy towards the question of democracy. Blending insights from international relations and democratic theory, it aims to enhance our understanding of the issues at stake. The main structures, the institutional setting and the procedures that govern decision-making in this domain are examined. In this way, the book supplements studies with a more traditional focus on the substance of foreign policy. What are the democratic challenges in this distinct field of policy-making?

The Common Foreign and Security Policy (CFSP) of the European Union (EU) is usually assumed to be intergovernmental. Contributors to this book examine the extent to which a move beyond intergovernmentalism has taken place, how this manifests itself, and what may be the democratic implications. While the EU's international outlook testifies to a quest for democracy, the institutions and procedures that govern decision-making are found wanting.

Originally published as a special issue of *Journal of European Public Policy*. ARENA-contributors also include **Erik Oddvar Eriksen** and **Chris Lord**.



ARENA organises a number of academic events each year, from large international conferences to smaller workshops. ARENA also organises regular Tuesday Seminars where external scholars as well as ARENA researchers are invited to present and defend their work.

In 2012, researchers also organised and chaired panels and workshops as part of international academic conferences organised by the International Political Science Association (IPSA) and the Research Programme on Democracy at the University of Oslo. Moreover, they participated at numerous academic events worldwide, including conferences organised by associations such as the European Consortium for Political Research (ECPR), the European Sociological Association (ESA), the European Union Studies Association (EUSA), the International Studies Association (ISA), the International Political Science Association (IPSA), the European Group for Public Administration (EGPA) and the University Association for Contemporary European Studies (UACES), in addition to giving invited lectures and academic papers at events organised by various research projects, networks and academic institutions.

Public defence:

Europeanization in a global context

Oslo, 27 September 2012

Christer Gulbrandsen defended his dissertation 'Europeanization in a global context. A study of a national maritime safety agency's work with global and European rules'.

Do the characteristics of the European executive order engender administrative behaviour by national agency officials that differ from those engendered by the traditional intergovernmental order, and if so, how?

That is the question Gulbrandsen asked in his doctoral dissertation, which is made up of three articles concerned with individual aspects of this problem within the maritime safety sector: The impact on practical implementation by 'street-level bureaucrats', the impact on administrative behaviour within a national agency and the impact on intra-EU coordination at negotiations in a global international organisation, the International Maritime Organization.

The dissertation finds three mechanisms whereby the EU changes administrative behaviour: Firstly, compliance with EU rules become more important than compliance with IMO rules. Secondly, the EU directly transforms the practical implementation of both EU and IMO rules. Thirdly, the EU imposes a coordination regime that fundamentally alters the relationship of EU states with the IMO.

However, the dissertation also finds three limitations to this transformation: Firstly, the IMO is a more comprehensive regulator within the sector. Secondly, the formal aspects of relations between nation-states and IMO have not changed. Thirdly, the EU is emphatically not granted any special status in the IMO, demonstrating that it faces

challenges in being recognised abroad as the kind of entity it is recognised as internally.

In his trial lecture Gulbrandsen discussed the topic: How does the Europeanization of the Norwegian Maritime Directorate compare to the theoretical mechanisms identified by the literature on the Europeanization of national political parties?

Democracy as Idea and Practice

3rd international conference *Oslo, 12–13 January 2012*

The Research Programme on Democracy, of which **Erik Oddvar Eriksen** and **John Erik Fossum** are members of the organising committee, held its third international conference in Oslo. The conference was inter-disciplinary, aimed primarily at researchers from the humanities, social sciences and law.

The conference opened with a plenary session chaired by Tore Slaatta (University of Oslo) on the topic 'Confronting the Unexpected: Democratic Ideas and Practices in Times of Crisis', with John Durha Peters (University og Iowa), Barbara Pfetsch (Freie Universität Berlin) and Helge Rønning (University of Oslo). A second plenary session chaired by Bjørn Erik Rasch (University of Oslo) was held on the topic 'The Arab Uprisings: Why, How and to What Effect?' with Ellen Lust (Yale University), Bjørn Olav Utvik (University of Oslo) and Cecilie Hellestveit (International Law and Policy Institute, Oslo).

During the conference workshops were held on the topics 'Political Parties and Media in Contemporary Democracies', 'Regionalisation and Federalisation: Democratic Implications', 'Political Communication in Times of International Crisis: Democratic Challenges' (co-directed by Hans-Jörg Trenz), 'The Rise of Democracy Through Constitutional Reform', 'Poverty and Democracy', 'Organizations in Democracy and Democratization of Organizations', and 'Conceptualization and Measurement of Democracy'.

Cosmopolitanism Contested

CEMES-EURECO symposium Copenhagen, 3–4 May 1012

CEMES and EURECO – in cooperation with ARENA – held a symposium on cosmopoli-

tanism in light of the current challenges to European democracy. Leading North American scholars were invited to enter a debate with their European colleagues on the future prospects of cosmopolitanism in Europe and the world.

The moderators were EURECO professors Ben Rosamond (Centre for European Politics) and Hans-Jörg Trenz (Centre for Modern European Studies and ARENA). Participants were Seyla Benhabib (Yale University), Richard Wolin (NY University and CEMES Honorary Professor at KU), John Erik Fossum (ARENA), Adrian Favell (Sciences Po), and Gerard Delanty (University of Sussex).

De-territorialized Diversity: Global and Transnational Dimensions

RECODE workshop *Oslo, 7–8 June 2012*

This workshop, co-organised by John Erik Fossum, explored a central issue of RECODE, namely the role of diversity with particular emphasis on the notion of transnational communities. Politics has traditionally been conceptualised and organised along territorial lines but the confluence of globalisation, cosmopolitanisation and Europeanisation have given new impetus to the development of transnational communities.

The workshop seeked to understand the nature of this phenomenon; how prevalent it is in the EU and Canada; what the implications are on minorities and systems of governing; and the nature and strength of nationalist reactions. The workshop was thematically organised to address these themes.

Innovating Governance in the Construction of the European Research Area

Oslo, 8 June 2012

The aim of this highly interactive one-day event, co-organised by **Meng-Hsuan Chou,** was to develop a research agenda on the European Research Area.

The starting point was that, although high on the EU political and policy agenda, the creation of the European Research Area is one of the most under-studied phenomena in European integration.

Specific questions that were explored in scoping the research agenda include: what is the European Research Area and what is its governance structure? How has it evolved and what is the relationship between this 'area formation' and others (e.g. the European Higher Education Area)? What are the pressing issues (e.g. legitimacy, effectiveness, or democratic accountability) concerning these developments?; and, are the theories and approaches we have for investigating European integration adequate to capture and account for its evolution?

The Transformation of the Executive Branch of Government in Europe

EuroTrans WP 1 workshop Oslo, 14–15 June 2012

The ARENA Lecture 2012: A cosmopolitan Europe

Oslo, 2 May 2012

- Breivik acted alone, but was not thinking on his own. There are groups in Europe that see themselves in a clash of cultures, a thinking that is based on myths of the history of Europe. We need to restore the vision of the cosmopolitan Europe, was professor Seyla Benhabib's message when she gave the ARENA Lecture 2012.

The myth of a Christian Europe

Samuel Huntington, the man behind the thesis 'clash of civilizations', has branded those who promote cosmopolitanism thought for 'dead souls'.

The myth of a Christian Europe as a battlefield for a clash of cultures has grown to prominence since 9/11. Much of this is built on historical fallacies.

Benhabib pointed out that the siege of Vienna in 1683, which has been an important event in the myth constructions, was not a clash between Christians on one side and Muslims on the other. It was rather an Ottoman campaign, supported by Muslims, Protestants and Orthodox Christians to protect Hungarian Protestants against the Catholic yoke of the Habsburgs. In the end, Vienna was saved by Polish forces with support from Lithuanian Muslims.

– Hardly the impression of a clash of religions, Benhabib stated. – Muslims have been as much a part of European history as other groups, from Muslim rule of the Iberian Peninsula for eigth centuries to the multicultural Istanbul, Benhabib's own birthplace.

The age of cosmopolitanism

The cosmopolitan ideas have roots back to Socrates, Locke, Rosseau and Kant. 'I am not a citizen of Athens', but of the world, Socrates said, according to Montaigne.

Since the Universal Declaration on Human Rights in 1948 the European society has largely moved from internationalism to

a cosmopolitan society, Benhabib argued. Rights based on a birthright as humans, not as citizens of a state or members of a nation are manifest in national constitutions and the treaties of the European Union. – These may not be steps towards a world constitution, but they are the constituents of a global society.

- The cosmopolitan idea may be a bit old-fashioned and has been attacked from left and right in the century of nationalism, the 20th century. From communitarians, neoliberal capitalists and from post-modernists. The term has been a placeholder for multiculturalism and imperialism. Its critics have missed what is new in this thinking, Benhabib argued.

A perfect storm

Europe is plagued by multiple crises that undermine the cosmopolitan ideals. Economic instability in a technocracy removed from people creates an insecurity that has led to xenophobia egged on by charismatic leaders. While the rest of the political elite is corrupt.

– In this climate, Europe's intellectuals have pointed out problems and scandals rather than the importance of dialogue with communities, Benhabib said. – I promote a cosmopolitanism without illusions, with an emphasis on inequality and diversity, grounded in humans a moral beings with the birthright to rights.

The 1814 Lectures: The constraining of Europe

Oslo, 22 October 2012

In his 1814-lecture, Jan-Werner Müller discussed how the fear of unconstrained collectivism helped shape the constitutional democracies of post-war Europe. Fear is also driving many of Europe's current populist movements.

- The two Latvian political thinkers, Isaiah Berlin and Judith Shklar, and their ideas can help us understand the development of constitutional democracy in mid-twentieth century Europe, Müller argued.

It was not the political language of liberalism that informed these developments, as these ideas were widely seen as having paved the way for the totalitarian nightmares of the century in the first place. These institutions were raised in the shadow of aggressive nationalism and state terror, but also out of fear of the totalitarian actions of unconstrained collective political subjects.

Two concepts of liberalism

In his famous inaugural lecture at Oxford University, Isaiah Berlin discussed two concepts of liberty. One of negative liberty based on non-interference, or 'freedom from' and another one of positive liberty based on the ideas of self-mastery, self-determination, and self-realisation, or 'freedom to'. Berlin warned that collective self-mastery could turn into collective enslavement of people, as it has shown to be susceptible to rhetorical abuse by authoritarian ideologies.

The anxiety of this concept of negative liberty is based on a fear of interference. – But, if you fear losing liberty, you have already lost liberty, Müller argued. An absolutely resilient and foolproof concept of liberty can in the end be foolish. An example of this is the Bush-administration's '1 per cent doctrine' that stated if there is the smallest chance of terrorism, we must do everything in our

ability to limit it, including losing some of our liberty.

The liberalism of fear

In his lecture Müller also mentioned a lesserknown political thinker, the Latvian Judith Shklar. Her term 'liberalism of fear' is based on her view that we need to fear a society full of fearful people because fear leads to cruelty and cruelty is the greatest evil of all.

Based on these views she advocates constitutional democracy. It is a flawed system, but still the best form of government possible, because it protects people from the abuses of the more powerful by restricting government and by dispersing power among a 'multiplicity of politically active groups'.

The constraining of Europe

The European post-war order had an antitotalitarian imprint, stemming from the fear of unconstrained collectivism. – There is an interesting link between constitutional democracy and totalitarianism, the fact that both are attempts to contain collective subjects, Müller argued. Hence you have the novel innovation of the constitutional court, which balances political values such as dignity, security, and liberty within

constitutional constraints. – The European Union and the Council of Europe do exactly the same; they add layers of constraints and rights protection, Müller explained.

– In the present times it is not collective self-enslavement or a master or tyrant interfering in our lives that we fear, Müller said. – We have an anxiety of loss of collective freedom, of our democracies becoming more constrained.

It is a fear of such forces, like markets, that are by many seen as illegitimate or unauthorised, that drive the populist political forces in Europe today. Be they right-wing nationalists, anti-capitalist social movements or pro-transparency groups like the pirate parties.

- For us today it might be a question of how we should contain these actors that may challenge our collective freedom today, Müller concluded.

Norway and the EU – A researchers' assessment

Oslo, 22 November 2012

With the Nobel Peace Prize to the European Union as a backdrop, ARENA researchers, in collaboration with 'Partnerforum', assessed recent developments in Europe and questioned how the Norwegian public administration adapts to the EU.

On the 12th of October the Norwegian Nobel Committee announced that the Nobel Peace Prize is to be awarded the European Union (EU). In its announcement the Committee's is that the union and its forerunners have for over six decades contributed to the advancement of peace and reconciliation, democracy and human rights in Europe.

With the Prize and an European Union in economic and political crisis as a backdrop ,ARENA in collaboration with 'Partnerforum' welcomed the audience to a breakfast meeting with researchers' views on the EU as a political actor in Europe and the world on the agenda.

The public administration is central in Norway–EU relations. It is essential that Norwegian officials in ministries and agencies have a good knowledge of how the EU develops and what this means for our country. The fact that the Union is in a
